CONDITIONS OF APPLICATION

Please read these conditions BEFORE completing the form.

A candidate for membership, whether adult or junior, shall be proposed and seconded by two adult members of the Club both of whom must be personally acquainted with the candidate.

Before any candidate is submitted for election his proposer and seconder shall write to the Committee stating what they know of the candidate both socially and otherwise. If the candidate is proposed for Seven Day Playing membership, the proposer and seconder shall also state what they know of the candidate as a golfer together with any special qualifications he or she may have for election. Also required are additional letters from two referees, not being from Monash Country Club, for example, people of good standing in Business or Professional capacities.

The names of the proposed candidates shall be displayed on Members Notice Boards within the Clubhouse together with the names of proposers and seconders, at least fourteen (14) days before the election to membership. Any objections lodged regarding the proposed candidate's suitability for election shall be dealt with by the Membership Committee.

An application requesting Self Nomination will be at the discretion of the Membership Committee, and must be accompanied by five (5) letters of reference from people who have known the applicant for two (2) years or more.

The Committee may hold the proposer and/or seconder of any candidate for election responsible for such candidate's entry fee and the first year's subscription or any portion thereof and in the case of a junior member the proposer and seconder thereof shall be liable for all amounts due to the Club by such a person during the whole of the time he/she is a junior of the club.

It is the responsibility of the proposer and seconder immediately a nominee is elected to membership to see that such a new member is introduced to other members, is advised of all the pertinent rules of the club, and above all, is sufficiently advanced in knowledge of the Rules of Golf to be competent to perform the duty of "marker" to a fellow competitor. The proposer and seconder must see that they play with the nominee until he/she is so equipped.

Before election to membership, the candidate will be required to sign an acknowledgment of the Conditions of Membership.

Handicaps

The eligibility to participate in any competition is that a member must have a current handicap obtained under the Australian Handicapping System approved by Golf Australia.

A member may have only one handicap.

If a member belongs to another club it is the member's responsibility to advise Monash Country Club in writing which is the member's home club.

Club Rules

It is the responsibility of all new members to ensure they have read and understood the Clubs Rules and By-Laws. Before approving a candidate, the Board requires the candidate to sign a Conditions of Membership form agreeing to abide by the Club Rules and By-Laws.
