Responsible Service of Alcohol

Asquith Golf Club actively promotes responsible service of alcohol.

Products may vary according to availability.

Confirmation of Bookings

A tentative booking must be made & confirmed by the Functions Manager. All bookings are considered tentative until signed Terms & Conditions form is received by the Club & a deposit paid. Tentative bookings will be held for 14 days.

Deposit

A deposit equivalent to the room hire charge is to be paid upon booking confirmation to the Club & will confirm your booking. A credit card is also to be supplied as a security bond. Refer *Excess Cleaning, Damage, Breakage, Loss of Property.

Board Approval

All bookings are subject to approval by the Board of Directors. Asquith Golf Club reserves the right to reject and/or cancel any function booking if it has reason to believe the said booking may jeopardise the Club's reputation or security.

Cancellation Policy

Cancellations must be made in writing to the Club. Cancellations made more than 2 months prior to the Function Date will receive a refund less 10% of the room hire charge. Cancellations within 2 months of the Function Date will result in a 100% room hire charge. Cancellations within 10 days of Function Date will be charged for contractor & catering expenses to the listed credit card. Any deposit paid for an external contractor booked by the Club will incur 100% penalty.

Final Numbers & Confirmation of Packages

Final numbers, menu selections & dietary requests must be confirmed 14 days prior to the Function Date. Catering will be provided for this number & this will be the minimum number charged regardless of last minute cancellations. If final payment isn't received by the Club, in full, in the required time frame we reserve the right to cancel the function. Last minute increases must be negotiated & paid in full prior to or on the day of the function.

Payment

Full Payment is required 5 days before the date a function is held, unless prior arrangements are made. Payment can be made by cash, cheque, credit card, EFTPOS or BPay.

Food Allergies

If any of your guests have allergies to any type of food please let the Club know as you become aware of it. We cannot guarantee there will not be any traces of the allergens in the food prepared at the Club. The kitchen use a wide variety of ingredients & it is therefore difficult to eliminate all traces of a particular type of food. The Chef & kitchen staff will do their utmost to ensure the allergen is not in the meals prepared. The kitchen reserves the right to serve a limited menu selection if notice is not given upon menu selection.

Children's Meals

Guests under age of 12 will be charged at 50% of the adult cost. All persons 12 years & over will be charged as an adult.

Function Times

For evening functions the function room is available for a five-hour period with the bar to close no later than 11.45pm. All guests must vacate the Club by midnight. Day functions are for a maximum of 4 hours & must conclude no later than 4:30pm. Any extension of function hours must be requested in writing prior to the Function Date. Charges will apply at a rate of \$150 per half hour beyond booked time.

Departure from Premises

We ask that you advise your guests to consider the local residents & leave the Club & parking area as quietly as possible.

Terms & Conditions

Terms & Conditions

Decorations

All decorations are to be approved by the Functions Manager prior to the event. Nothing is to be nailed, screwed or adhered in any way to any wall, door or other part of the Function room. Glitter, confetti & similar materials are prohibited & a cleaning charge will apply for any debris. Should the premises be left in an unacceptable state, a cleaning fee may be charged to your listed credit card.

External Contractors

The use of external contractors is subject to management approval. The Club requires details of all external contractors (e.g. musicians, photographers, etc.) prior to the Function Date & reserves the right apply limits/restrictions on these contractors so as not to impact on the venue & surrounds. All music must conclude by 11.45pm & the premises vacated by 12:30am, otherwise an additional charge of \$150 per half hour will apply to the hirer.

Licensing Laws & Guest Lists

It is a requirement of the licensing laws that a full guest list containing names & addresses of all the guests in attendance be provided to the Club prior to the event, or all guests of your event will be required to sign into the Club upon entry.

Responsible Service of Alcohol

Asquith Golf Club abides by the Responsible Service of Alcohol & reserves the right to ask intoxicated persons, minors or those persons whose behaviour is considered as disorderly to leave the premises. It is the hirer's responsibility to ensure orderly conduct of their guests, especially when leaving the premises at night. Management reserves the right to terminate the function without refund of any monies should disorderly behaviour present a problem.

Underage Guests

Underage guests must remain under the direct supervision of a responsible adult at all times.

*Excess Cleaning, Damage, Breakage, Loss of Property

The hirer is responsible for the safekeeping of personal belongings, merchandise & gifts. All care shall be taken for your property, however no responsibility can be taken by the Club. If required, you should arrange your own personal insurance. The hirer is responsible for any damage to the building, facilities & furnishings on the property & for any loss arising as a result of any action by your guests or contractors. Any cleaning fee, damage or loss resulting in liability will be advised with 14 business days & will be charged to the listed credit card.

Security

Should your function be for the purposes of celebrating a 19th to 21st birthday or school formal (or other function as determined by the Club), it is also a requirement that security is present for the duration of the function. Minimum 1 security guard for less than 80 guests & minimum 2 security guards for greater than 80 guests. This service will be organized by the Club & the costs will be payable by the hirer directly to Asquith Golf Club.

18th Birthday Parties

The Club does not accept bookings for 18th Birthday parties for non-member bookings. For Member bookings of 18th Birthday celebrations a letter of special request must be written to the General Manager of Asquith Golf Club for approval. Security is a prerequisite.

Price Variation

All prices quoted are subject to variation up to the point where final payment is made. Notice will be given in writing of changes. Annual increase will be at the discretion of the Club. Price & menu changes will take place annually with notice given.

Surcharges & Cakeage

All prices quoted are per person & include GST. A surcharge applies of 10% on Sundays & 15% Public Holidays. Celebration cakes are welcomed, a cakeage charge of \$2.50 pp will apply for kitchen to cut & plate.

Still photography, videography & social media

Asquith Golf Club reserves the right to use still photography & filmed footage for marketing purposes. The Club will respect the hirers privacy on the date of the event & no social media will be linked to your event however Asquith Golf Club does reserve the right to use all photography, video footage & testimonials for all social media platforms to promote the venue after the event date. These platforms include but are not limited to Facebook, Twitter, Instagram, Pinterest etc.

Indemnity

Asquith Golf Club uses the freshest & best available food & ingredients & prepares food under the most hygienic conditions. However, no liability is accepted for any defect in any products used by Asquith Golf Club or any loss however arising there from.
